• ReLeaf Lake Mac

Think Tank held 29 September with range of stakeholders to identify opportunities and challenges. Included reps from range of organisations including Council, Landcare, and interstate.

Currently planning project to apply for Environmental Trust Education Grant, up to \$60k, 2-3 years. Application is due 16 November.

Noted with interest the chart (draft) available that lists canopy cover percentage by suburb.

• **Coal Ash Dam parliamentary enquiry** – Steve attending 6 October at Council building, and circulated his submission.

Lyn Fraser from WBSNG and Steve presented their submissions, backed up by CNN and

Keep Lake Macquarie Clean, to the NSW Upper House Inquiry and the Alliance's verbal submission was based on our longer submission prepared by Lyn.

Steve emphasised the heavy metal leaching into the Lake, the threat posed by a collapse as happened in 2008 in USA, and the closure of Myuna Bay SRC. Steve answered a question about the inadequacy of just planting over the top of the present unsealed 2 ash dams, and the much better solution of reusing the ash in cement, road building and tile making. The Inquiry did an on-site inspection. More evidence is coming out about the dangers.

Well done to Lyn and Steve for their work on this project.
