Welcome and acknowledgement of Country

We acknowledge the Awabakal people, as the traditional owners of the lands around Lake Macquarie, and paid respects to Aboriginal elders past, present and emerging, and to other Aboriginal people attending.

ITEMS FOR DISCUSSION

1. Business Supporters

Three businesses have signed up as supporters so far.

http://www.sustainableneighbourhoods.org.au/supporters.html. Two are businesses run by SN volunteers, and 1 was recruited by Gab through a networking opportunity.

A number of approaches have been made so far eg through Five Bays and Plastic Free Cafes project. Businesses (maybe 50% ish?) seemed keen, but have not followed through yet.

Some recruitment ideas:

- Request to SN groups for feedback. How many businesses have they visited and/or followed up with? Have they gotten a sense from them about willingness and/or ability to sign up?
- Could do a social media campaign to encourage new sign ups. Haven't done any yet.
 Could highlight our 3 existing Business Supporters. May help encourage people over the line who have been approached already.
- Personal approach is likely to be most successful. Encourage and clarify with SN members to seek out people they know who have local businesses.
- Some clarity / more specific about what we intend to do with the money.
- Also promote more tangible benefits to businesses eg potential for promotion opportunities. Balance between promising and volunteer workload/capacity to follow through.
- Request to do a presentation to local business chamber

2. Mutual obligation registration

We received a request from the Cardiff Area SNG about registering as an organisation with Services Australia (Centrelink) to allow volunteers to count their SN hours as part of their mutual obligation requirements.

The Alliance <u>can apply</u>, and if approved, a relevant SN representative can then sign a volunteer's '<u>Verification of voluntary work form (SU462)</u>' for the relevant period.

Note that it will only be suitable for volunteers who are doing a regular, predictable role, and not for roles that are ad hoc or short term. It will be important for the volunteer and relevant SN group to maintain accurate attendance records, but we should be doing that for all volunteers in any case.

Proposal: The Alliance to apply to register as an organisation with Services Australia (Centrelink)

ACTION: Gab to complete the form and submit in person at Centrelink service centre.

3. Local group visits

Reminder about purpose of board member visits. Suggested talking points

- Some citywide projects they can get involved in, eg Business Supporters and Plastic Free Cafes

• Redhead – Steve

Redhead is a great group regrouping after Colin move away. Their newsletter and social media are important, the new Boardwalk Brews Cafe is advocating sustainable living, there's also a market once a month. Their Energy Wave project has possibilities for other SNGs. They mentioned Nova's Community Energy. Awaba Battery was discussed. The Redhead BMX track is going ahead despite late community opposition.

Issues: the changes to Bulk Waste were not popular, particularly as many jobs in pick-up recycling would be lost. I mentioned the Green Shed Recycling in Canberra could be copied at Awaba Tip. Last few days' storms have left the beach littered with small plastic pieces. Need for beach cleanup! Small plastic sticks very evident. I pointed out that Sydney Water upgraded their sieve system at their plants as these sticks are from cotton buds. Also, balloons and their silver blowup containers were everywhere as people had parties! I think it's time for a ban!

4. Renewing Sustainable Neighbourhoods

Survey reports now completed, just waiting for review, and will be sent out to participants & board when approved. Received 244 responses (4% return rate) from Sugar Valley area, and 492 (5% return rate) from Belmont area.

Planning for gathering events in late August/early Sept. Intend to invite board members and/or representatives from local groups to attend and talk with new participants. Noted value of having existing volunteers at previous events.

5. National Volunteer Week celebration, 22 May

45 attendees from Landcare and SN. Nice to have a combined event, and interesting talk on seagrass from Janet White. Well organised and enjoyable event.

6. Valentine Our Place Our Patches, 4 June

Walking tour of local gardens. Generally well received by attendees. 20 people in total with two from VSNG. Anna & Gayle were the tour leaders. Some discussion on what worked well and what we could do differently next time. Idea to showcase fewer properties and have some more in-depth coverage on easy 'no-dig' gardens, improving your soil, edibles, bird attractants etc.

7. Toronto pop up stall

On Saturday June 4, Toronto Area Sustainable Neighbourhood Group held a stall in Toronto to celebrate World Environment Day on the Sunday and alert the public about the ban on single use plastic bags (including bio and compostable bags) on June 1. We had a number of handouts including cloth reusable bags, low water shower heads, and especially the net veggie bags! Handouts for living sustainably proved very popular. A petition to get Coles, Aldi and IGA to follow Woolies' phase out of the cheap, 15 cent, thicker plastic bags was signed by many people, and later given to Managers of those supermarkets.

Possible future event at Fennel Bay markets.

8. Work Health Safety training, 15 June

11 attendees. Valuable session to understand risk management process and health & safety obligations for volunteers.

Rachelle planning to develop online Health and Safety training tool to help make important content more accessible for more volunteers.

9. Repair Café, 12 June

Went great – relaxed. Estimate 60 people attending. Fewer repairers than usual but benefit was to have conversations with people. Lots of learning.

Looking forward to Rathmines event 23 July.

10. Plastic Free cafes and coffee trucks

36 cafes and coffee vans engaged to distribute reusable coffee cups. 2000 cups – nearly all gone.

Media release and promotions went well. Interview 2NUR

Based on the Community Environment Grant, we managed to spread the \$2 Bamboo reusable coffee cups to 35+ cafes and coffee vans from Cameron Park to Wyee and West Wallsend to Redhead. Tried to target smaller coffee places doing it tough and as many coffee vans as possible, although hard to find as they move around a lot! Only 1 cafe in Caves Beach did not want to participate. All the others found it a win-win, were so supportive. This No 3 give-out has been popular, but emphasised to public to clean the cup thoroughly and don't forget to bring it when you go to get coffee. Didn't have enough money to push metal straws and other non-plastics. Thanks to SNGs who helped. Hope to use remaining \$300 buying a few cups as part of Choose to Reuse at Living Smart Festival. I did hand out business contributions leaflet...will emphasise it when I visit them again.

11. ReLeaf

Blackalls Park site has been approved.

We have money donated for the cost of the plants and ReLeaf banner has been made that can be used citywide. The money for that has also been donated.

Our next hurdle, which I am working on, is the mulch. We need to use a composted forest mulch. LMCC gets theirs from OZ Mulch. There could be a cost involved, especially as the site needs 34 m3 of mulch. I am now raising funds for this. Donations welcome.

Hopefully we can assist Rathmines SNG as they are in a similar situation with the mulch.

There are 8 weeks till NTD.... Lots happening.

ReLeaf team noted that the engagement report relating to 3 recent strategies put to Council eg <u>Urban Greening Strategy</u> (pp56-60) resulted in very few changes made in response to community feedback. Some members noted a historical pattern.

TASNG decided to continue the message of "Recycle and Reuse" (including bamboo reusable coffee cups) at the Living Smart Festival in September and the mooted car boot event in October. The next ban on plastic straws, plastic cutlery and plates, plastic cotton buds and microbeads is due on November 1 this year!

Some great waste audit data from Council – Local info about specific contamination items that would be good to focus on.

Recyclemate website – help to find recycling options for lots of items.

Raffle for ReLeaf fundraiser - idea.

Rachelle to convene project team meeting to progress.


