1. Alliance 10 Year Anniversary – 7 July 2021

Coastal Zone Management Committee Meeting Report 20/04/2021

Cr Langford flagged possible SN support on a couple of items, for example Operation Posidonia – a program to monitor and revegetate vulnerable lake seaweed (Posidonia).

Suggest Alliance board can address any relevant items and items can be raised at upcoming CZMC meeting. We should take the opportunity to be proactive where we can.

4. Draft volunteer Code of Conduct

Draft Code of Conduct for SN volunteers has been developed as part of our refresh of Alliance governance. Draft has been circulated to board members for review, and mentioned by Alliance board members at a few recent local group meeting visits.

- Suggested changes to the text to soften the wording as board member feedback.
- Aim to collect feedback by mid June, to present final draft to June board meeting for formal adoption.
- Start using updated Membership Forms from July when groups will be renewing their memberships for 2021-22.

Cardiff Area	Steve	 Confirmed NTD site on July 24 Supportive of 10th Anniversary stall July at Farmers Market Business Supporters Plan approved, although work involved in getting small business supporters. Liked citywide projects eg coffee cups. Some unease / problems with Code of Conduct. Could be seen as over the top. Particularly unhappy with Council's frequent lack of consultation with SNGs – particularly around property development and destruction of bushland, eg at Myall Rd. Local Projects: Wreath Making, Pollinator Corridor, protect Munibung Hill, Frog Pond Workshop, Save Myall Rd bushland, Swap Library, help Repair Cafe WB, Car boot sale, Boomerang Bags, Cardiff North School Community Garden, CASNG newsletter. Need help from Alliance regarding casual hire of Council Halls. Casual hirers are not currently allowed at any council halls because of covid concerns and unreasonable risk aversion. What do we do if Council disconnects from Sustainable Neighbourhoods? Need help to advertise SNG events. Council has recently disallowed community events on their events page Council often doesn't consult transparently. Need Alliance to help set up more communication with Council - maybe a regular consultation.
Valentin e	Gab	 Thoroughly enjoyable planning meeting - full of passion and commitment. They discussed the planning meeting. Good opportunity to remind them about governance requirements. Sent a thank you email with links from our web page, regarding governance and planning. 10yr anniversary, very excited about supporting the workshops and a Repair Cafe "the heritage shed will be a good place to do the Repair Cafe

- and showcase what we do" maybe with a photo display or video imaging. "like the idea of walking into a variety of workshops/activity tables.
- National Tree day, some concerned were shared regarding people's attitude towards trees. Explained it was only Landcare sites and we are there to assist them, if they wanted to collaborate with other local volunteer groups.
- Business supporters were not talked about, we ran out of time.
- Several times we were referred to as 'the council' e.g the council will check our risk assessments, council will contact all our volunteers, council will give us the hall. I clarified this every time.
- I feel this experience has certainly benefited the group and myself.

ACTION: Rachelle to collate and send around to groups when we collect a few more reports over coming month.

ACTION: Steve to enquire with Cr Fraser about potential to set up regular meeting with Council liaison. Noted that many aspects of Council engagement are proactive, but main problems have been around inappropriate developments.

Both parties are interested in the tree trail concept at the MAC Sculpture Park. All approve the concept of 'Aboriginal name, common name and scientific name' last. The Blackalls Park site is under investigation on HOW to safely implement the planting project. It will happen, not sure when.

17. Greater Charlestown SNG – current projects

18. Redhead - succession planning

A couple of crucial volunteers are moving away from the Redhead area, and therefore the Redhead Sustainable Neighbourhood group.

They have started a succession planning process to encourage existing and new volunteers to take up the administrative workload and coordination of the group. To date have summarised the different organisational tasks and project related work, as well as documenting the many achievements towards the groups SNAP: sustainable-neighbourhood/snap.

A great example of an approach to planning for volunteer succession and handover.

19. Cardiff Pond and Tree planting workshops

20. Cooranbong SNG

Harwood (Avril's partner) has been in touch to seek advice about funds held (~\$300) by the Cooranbong SNG. Rachelle suggested to consult with other bank signatory and either donate to SN Alliance / or to nfp community group in Cooranbong. They are talking with their other committee member to confirm and/or investigate whether there is interest in renewing the group.

21. Muddy Lake, Dora Creek

Rachelle assisting members of Coal Ash Community Alliance with Salvinia infestation at Muddy Lake, Dora Creek. They approached the SN Alliance about a possible grant application and project to engage with their neighbours around this issue. Upcoming meeting with Council and Crown Lands staff to understand current management actions.

22. Plastic Free Lake Mac

Remaining Bamboo Coffee Cups, Signs and money boxes from nearly 40 cafes have been collected. Each café received a Certificate of Appreciation.

The feedback from Cafes has been really great - people are reusing them and cafes are keen to move to Plastic Free status.

Future plans: Save the leftover coffee cups for a campaign in Spring targeting coffee trucks. May also need an environmental grant. Will bank the money in the money boxes (as Plastic Free Cafes money), hopefully to use it in the spring campaign.

Considering applying for a new grant to focus on coffee trucks – next Community Environment Grant round.

24. Networking - film screening

Gab attended a film screening and local climate action update at Pachamama House in April. The film was "Beyond the Burning" a look at the 2019 fires of the Victorian Gippsland, quite upsetting and inspiring at the same time.

Climate Action Newcastle, Hunter Community Environment Centre, Newcastle Climate Change Response and Beyond Zero Emissions, hosted by James Whalen.

James and Jo from HCEC mentioned the SNA from Lake Mac, which provided an opportunity to converse with other locals, although all from Newcastle, but our name and activities are getting out there, most knew about "The Waste To Art" and "Repair Cafe Lake Mac.

26. Business supporters – Membership platform costs and options

Researching online platforms that will be able to:

- Make it easy for Business Supporters to join up and donate annually
- Make it easy for individual financial members to join and renew their memberships annually.
- Reduce administrative workload involved in managing memberships & Business Supporters
- Accept online payments from the public
- Manage membership automatically including joining, renewals and automatic reminders

We've identified two platforms that may be suitable (JoinIt and Raklet), as well as a couple of options for online payments, but no membership management (Humantix and Stripe). The key features, and costs of each platform have been circulated to board members.

Each of the platforms will cost a fair amount, ranging from 12-127%, depending on the number and amount of transactions that are processed. It puts some pressure on recruiting enough supporters to make it worthwhile. (Eg if we only got 30 small business supporters, the platform costs would take up 40-60%.) Is that an acceptable cost to make money?

Questions for discussion:

- Is there a willingness to accept the costs of the platform in order to make Business Supporters and individual memberships more manageable?
 - First investigate how many Business Supporters we will be able to recruit, to help judge the potential benefit/cost of a membership platform?
 - Do we / SN network have capacity/commitment to promote and recruit enough Business Supporters to make the platform worthwhile?
 - o Could trial the platform for 6-12 months and accept initial \$\$ outlay.
- Individual memberships
 - o Relatively simple if people just want to join Alliance directly.
 - How to manage local group memberships to maintain local ownership and income. Eg could set up for people to choose which local group they are

- joining. If platform allows multiple bank accounts, the payment could go direct to group.
- Platform has potential make managing memberships easier for local groups, and to encourage automatic renewals etc.
- Will transaction costs take up too much of small individual membership fees (eg \$2-5)
- JoinIt is probably the preferred platform. If we agree about the costs in general, Rachelle to invest some time to set up the JoinIt platform as part of a 30 day free trial.

27. Ban on helium balloons

Request from Gayle (Valentine SNG member) regarding advocating for a ban on helium balloon releases in Lake Mac, following Council screening of film, Rubber Jellyfish:

A number of councils in Australia have developed policies on Helium balloons to ban any release of them - and effectively to help stop their use. Margo suggested that people may want to urge councillors to take up this issue and to urge Lake Mac council to follow suit. I thought the Alliance would be a good place to start.

Am interested in your thoughts on this and what you might suggest as a way to take this further.
