Meeting opened 6.02pm

1. Welcome and acknowledgement of Country

Gab welcomed everyone to the meeting. Gab acknowledged the Awabakal people as the Traditional Owners of the lands around Lake Macquarie and extended respects to Elders past and present. She also encouraged everyone to walk on Munibung Hill and noted that the area is a special place for Awabakal people.

ITEMS FOR DISCUSSION

2. Bank signatories

At the July meeting Mackenzie noted that he is signed up as a signatory, but doesn't have a user name and password to be able to access the Alliance's internet banking account.

Mackenzie emailed the board to note that this is in progress.

3. Hunter Community Alliance update

Following last month's discussion, David Barrow (Organiser, HCA) has approached us to see if he can attend an upcoming board meeting. We also received a request from the Greater Charlestown SNG to invite David to speak with the board.

Proposed talking points to ask David about:

- Purpose and objectives of the HCA
- their current projects, priorities and achievements
- what are the roles, rights and responsibilities of member organisations

Resolution: Rachelle to invite David to attend the September board meeting to talk to the above points.
