#### 7.1 Living Smart Festival and Plastic Bag Campaign

Confirmed activities for LSF include:

- Encouraging people to sign the form letter to Minister Mark Speakman about actions to reduce plastic pollution.
- Waste displays supplied by WWSNG, and promoting alternatives to disposable plastic (ie reusable bags, bring your own coffee cups, local plastic bag free champions etc)

They coordinate a national campaign around plastic pollution, <a href="www.boomerangalliance.org.au">www.boomerangalliance.org.au</a>, and can provide support, especially in terms of networking and coordinating with other groups around Aust, and promoting successful projects and campaign actions.

Lisa also provided a form letter to use at public events, and update of current campaign activities.

  facility.

#### **HUNTER WATER COMMUNITY CONSULTATIVE FORUM REPORT**

to

#### LAKE MACQUARIE SUSTAINABLE NEIGHBOURHOOD ALLIANCE BOARD

Meeting, 13 September, 2016.

On behalf of the Alliance, I attended the above meeting of Hunter Water Community Consultative Forum (the Forum), which was held at the Burwood Beach Wastewater Treatment Plant (Burwood Beach). Burwood Beach was established in 1936 and is located at Off Scenic Drive, Merewether. To say the least, it was an interesting part of our local area, part of Hunter Water's operations, to visit, and a place I had known about for most of my life, but not actually seen. Burwood Beach provides waste water treatment services to 30% of Hunter Water's total commitment. Burwood Beach is now operated by a private contractor, Veolia.

#### **REVIEW OF HUNTER WATER COMMUNITY CONSULTATIVE FORUM**

For Hunter Water, 2017 represents its 125<sup>th</sup> year of operation. In light of this, Jeremy Bath, Chief Customer Service Officer, announced that a review of the Forum, its composition and its services, would be conducted during the remainder of the year. His uppermost aim is to widen the Forum's impact and make changes across what the Forum is doing, to better service the wider Hunter Water community.

Changes in property development requirements now mean that 'enclosed communities' are in existence where no water or sewerage services are provided by Hunter Water. One such community is located in the new development at Cooranbong.

#### INTRODUCTION OF NEW MANAGING DIRECTOR

Our Alliance had no matter before this meeting of the Forum, but the introduction of the new Managing Director (MD) of Hunter Water was made. The MD is Mr. Jim Bentley, an Englishman, who for the past 10 years has been working in one of New Zealand's universities.

His experience prior to New Zealand has been in a water service operation on the south western coast of England. This was a privatised operation. In his address it became clear that he is quite positively disposed to privatised operations.

#### **PRESENTATIONS**

#### Stephen Marks, Wastewater Treatment Planning Engineer

Upgrades are being undertaken at Burwood Beach for disinfection of waste. After research and review, UV Disinfection systems are being installed at Burwood Beach to treat waste and will be commissioned in March 2017.

The disinfection method is tied to the amount of waste passing the disinfection UV locations, of which there will be six. The cost of this method of disinfection is \$14 million dollars. This method of disinfection will also treat some viruses.

Stephen Marks also pointed out that severe wet weather means that the waste water stream is not disinfected, but goes out to ocean disposal. The end of the disposal pipe is 1Km out to sea. Severe weather can mean that waste can be blown in the direction of the wind, up the coast or down the coast.

#### Jordi Bates, Water Resources Team Leader, Planning.

Seaham Weir Pool Erosion Study

Seaham Weir Pool is 20kms upstream on the Williams River. The last studies in this area were in 1968 and 1978. The Seaham Weir Pool is a primary source for drinking water. Erosion of the banks of the river/pool have increased

the level of nutrients in the water leading to the development of algal bloom development. This has resulted in increased turbocity.

The Report from this study will be released on Monday 19 September, 2016. Its findings will show the following:

- deterioration in erosion
- boating is increasing susceptibility to erosion
- three-quarters of the weir pool was found to be moderately erosive or worse
  - o 28% needs immediate management
  - o 68% needs ongoing monitoring
  - 4% requires no action at this stage

#### Recommendations

As there is limited opportunity to redirect boating traffic, and the relatively narrow width does not allow redirection of boating pathway some difficulty is experienced.

#### Stage 1 Management Action Plan sets out:

- immediate riverbank remediation
- weed removal
   I This is NSW Govt RMS management
- revitalisation of native vegetation

#### Stage 2 Management Action involves:

- revegetation/structural works
- management of revegetation works
- release of Williams River Report 19 September
- facilitation of development of interagency by TINSW

#### **Darren Cleary, Chief Operating Officer**

#### Williamtown Reticulation Project

- currently the project to deal with Williamtown contamination is on track for 2017, commencing in Farm Cove and Lauers Lane
- designs for Salt Ash are nearing completion
- eligible residents have until March 2017 to notify intent
- Hunter Water will provide connection point inside fence line of property, owners will have to employ a plumber to complete connection of property

#### Campvale Surface Water Catchment

- pump station must operate
- pump station was constructed in 1962
- pump station pumps from Campvale to Grahamstown Dam
- pump station only operates in wet weather, NOT dry
- PFOS/PFOA evidence detected in Campvale Pump Station
- lifetime exposure basis for determination of acceptable PFOS level
- PFOS/PFOA testing now ongoing
- evidence of PFOS/PFOA has been found in household dust at much higher levels than in water and waste water

The meeting closed at 12.15pm. The next meeting will take place in February 2017 at a venue to be notified.
