## 1 Welcome & acknowledgement of Country

## 4 Previous meeting

#### 4.1 Ordinary meeting minutes, 21 June 2016 as tabled

#### 4.2 Business arising from the minutes

#### Dog management

- Rachelle confirmed that Council is able to donate 500 'pooch pouches' to the Alliance to use as giveaways as part of this project. (A 'pooch pouch' is a little pouch to attach to a dog's lead, that can carry bags to pick up their poo so that dog owners always have a bag with them.)
   (Pricing depends on the number of pouches, but up to ~\$3.50 each. Probably no need to purchase any, considering that Council can donate them.)
- Steve reported that Edinburgh Council has designated dog poo bins, but there are sometimes
  problems with bins overflowing and smelly if not collected regularly. They also give away scoopers
  with bags, but unsure of the type of bags used.
   Steve also did some research about 'poo-scoopers' a plastic claw / handle to help people pick it
  - up and avoid any direct contact with poo. They are cheap (<\$10), and some come with biodegradable plastic bags.
  - Another version uses a piece of cardboard with a metal frame and plastic bag.

PROPOSAL: Suggestion to purchase some 'poo-scoopers' to use as demonstration at the Living Smart Festival stall.

Recommended scoopers to purchase - 2 that can be attached to a belt or hand and easy to carry. They both open up like hand claws and bag inside (so hands don't touch the poo}, and should be quite cheap. Maybe, they are available in Australia??

RESOLUTION: Approval to go ahead and purchase 2 poo scoopers to trial and demonstrate at the LSF, and to use to gauge people's reactions and likelihood of uptake.

- Steve also reported back about producing energy from methane, which is done in a number of places around the world.
- From Rachelle Council currently captures methane produced from the Awaba landfill, which contributes a small amount to energy production. Council's plans for the new green waste system are for it to be an aerobic system, so that it won't produce any significant amounts of methane. Faeces will not be collected in the new green waste system to prevent a variety of health risks.

OUTSTANDING ACTION: How can we maximise the petition by linking up with the main NSW Campaign? Rachelle to contact Plastic Bag Free Alliance.

How can we use publicity about the petition, Champion Businesses/Responsible Cafes, role of the supermarkets/fast food outlets, other plastic pollution-plastic bottles, coffee cups, straws, caps, cotton buds, L and P plates, etc. in the lead-up to the Living Smart festival?

#### PROPOSAL:

- That the Alliance will seek publicity (newspaper, TV, radio) for the petition and the Champion Businesses, and Responsible Cafes during the lead-up to the Living Smart Festival. Highlighting that there is a campaign to ban plastic bags in NSW, and to encourage further support.
- At the Living Smart Festival the Alliance stall will focus on a display of some collected plastic rubbish that is present on our beaches and around the lake.

ACTION: Colin to enquire with Ocean Pod display to see if they are interested in attending the LSF – in conjunction with us?

ACTION – Rachelle to enquire whether OCCI are holding their own display of marine debris and if not, can we borrow it?

#### 7.3 Review of Sustainable Neighbourhoods

As discussed at the March Alliance meeting, Council staff have been progressing plans for a review of the Sustainable Neighbourhoods program. A draft engagement strategy and schedule has been circulated via email.

Of particular relevance is the request that board members are directly involved in the process and engage directly with the network of local groups. For example, the proposal involves Council staff attending each of the local group meetings between Aug - Oct. It is desirable that at least one board member (not from that local group) attend as well, to give the network an opportunity to meet board members and discuss the future of the organisation.

PROPOSAL: Council staff are seeking endorsement and support from the Alliance for the implementation of this plan. In particular, seeking board member assistance to engage with all local SNG membership.

RESOLUTION: Endorsement to go ahead with the plan, and enthusiasm for board members to participate.

Additional suggestion to ensure that contacts from inactive groups are included as much as possible.

## 9 Report backs from member groups

#### 9.1 Caves Beach - Swansea Area SNG - Marine Debris Clean Up, 3 July

#### 9.2 Cardiff Area SNG – Bunnings Sausage Sizzle fundraiser, Sunday 26 June

The sausage sizzle was very busy and hard work for volunteers (10 volunteers contributed a total of 51) hours, but was successful as a fundraising activity, raising over \$1000. The additional benefit was that they had contact with about 600 people buying sausages who now know about the Cardiff Area SNG.

#### 9.3 LT Creek SNG – Awaba State Conservation Area Campaign update

- The first children's story about the area has been drafted by Evelyn who is 10. Glinda has been seen in Canberra.

- Wildlife Rescue (NATF) have written an article about Awaba SCA (p) in their latest newsletter.
- Origin Energy Eraring and Centennial Coal Newstan have been introduced to Glinda.
- The Lake Macquarie Sustainable Neighbourhood Alliance and Coal Point Progress Association have endorsed LT Creek SNG's work on Awaba SCA (P). Cooranbong and the CEN have added their endorsement. Waiting to hear from new Chair Wangi. Logos of Community Groups, and NGO's are on the website. <a href="https://conservewestlakes.wordpress.com/awaba-conservation-area/supporters-of-awaba-sca">https://conservewestlakes.wordpress.com/awaba-conservation-area/supporters-of-awaba-sca</a>.
- Gates are in place at the Hawkemount Rd and Freemans Drive intersection. This has been a
  joint venture between Centennial Coal and LMCC. This is to assist in the prevention of illegal
  dumping and dumped cars.
- Negotiations between Centennial Coal and Crown Lands are still on the table in regards to the illegal dumping issue and land ownership.

- Glinda's representative asked a question at the recent Candidate Forum, for the Federal Seat of Hunter, about how the candidates would assist LMCC in protecting and managing bushland in west Lake Macquarie.
