#### 5. New bank account

Agreed at August meeting that we need to switch to internet banking, so that we can make payments more efficiently. Feedback from Greater Charlestown, Warners Bay and Toronto SNGs that they've had a positive experience with the Greater Bank, and that their online system is simple to use. Also noted that it will be good to divest from the Commonwealth bank considering their poor treatment of customers and ongoing investment in fossil fuel industries.

## 12. Reports / current project

### 12.1. Plastic Free Cafes – Choose Reusable

Grant agreement has been signed and submitted, so expecting first instalment payment this month.

Still waiting for Minister's announcement before we can publicly launch.

Project materials and media release have been drafted. Thanks for feedback.

Planning to place cup order for 600 asap to secure cheaper prices. Will be 25 cups each for cafes in Toronto and Warners Bay. Sample cup was shown to the meeting – made from silicone, collapsible design. Trying to identify silicone recycler

Seeking feedback on design for band around cups. Note print area is 40mm x 20mm – Alliance logo + wording: Choose reusable

Decided to sell for \$2 each, and to replace the expensive cardboard display boxes with a small sign, which will give cafes more flexibility to display. Signs will be designed this week. Have bought some Aldi metal straws to offer cafés as an option. Official invitation to go out to cafes (all have already agreed). February launch and media. Will get some more cups in July, when we receive second grant instalment. It would be good to include a few more cafes in other locations at that stage.

Encourage cafes to move out of other plastics, spoons, bags etc as part of this campaign, and not forget about fastfood restaurants. Toronto is also encouraging Woolies/Coles/Aldi to reduce plastic packaging...big victory Reject Shop has stopped free plastic bags..you have to buy one, but only 15c not \$1 in our Senate submission.

## 12.2. Submission in support of Product Stewardship Bill

Steve and Nico developed a submission on behalf of the Alliance to support the Products Stewardship Bill, including support for the seven key measures outlined in the Bill, and additional amendments including in brief:

- Mandated recovery target for all packaging including requirements on recycled content
- A ban on single use plastics
- A ban on polystyrene containers
- Clear labelling requirements to specify what can be reused, composted or recycled
- Labelling requirements on other problematic products
- Greater industry responsibility for collection, recovery and litter clean up costs
- Expanded container deposit scheme
- National single use plastic bag ban, and increased price for 'reusable' plastic bags

#### 12.3. Submission on Hunter Water Desalination Plant Environmental Impact Statement

Meeting with Hunter Water staff held 5 December. Information about the desal plant proposal available here: <u>https://yourvoice.hunterwater.com.au/desal</u> or brochures available.

Consider that it is likely HW will push ahead with preparations for the plant in any case, but

worthwhile for Alliance to make a submission outlining concerns. Robyn and co have drafted and circulated the draft submission and will go ahead and send tonight. Draft submission states the Alliance's position against the proposal, and raises a number of concerns, including in brief:

- Potential impact on nearby coastal wetlands and Endangered Ecological Communities.
- Impact of brine outflow into the marine environment.
- Groundwater management during construction.
- Increased energy use and carbon emissions and inadequate green energy use
- Potential dune erosion and disturbance at intake point.
- Consideration of alternatives
- Increased focus on demand management and behaviour change

#### 12.4. ReLeaf Lake Mac

Jonathon and Robyn had a meeting with Rachelle and Graham. LMCC still sorting things out. Symon Walpole is responsible for developing the Urban Tree Strategy.

Alliance considering a grant project to community awareness and education and tree give aways for appropriate resilience against climate change.

Zoom meeting held on 3 December. Gabby, Jonathon and Robyn in attendance. Next meeting will be the 16 Dec. Next meeting with Graham is 10 Feb 2020.

The board requested meeting minutes / notes and more details about the project activities to encourage broader participation from SN network.

Ran smoothly. Planning to talk with organisers of successful Sydney Repair Café to see how they have made it work so well.

- Stall at Cardiff community fair Cardiff
- **Toronto Picnic** Toronto and Five Bays. Event went well 100-150 people attended. The weather was kind. Relaxed and positive feedback from participants.
- Awaba Rd opening Toronto 50 people attended to celebrate the opening of the new garden on Awaba Road, improving the streetscape and welcome to the city.
- Waste free Christmas Cardiff
- Coastal Zone Management Committee Meeting (Dec) Colin
   Dune Management and Recreational Needs studies undertaken by the Belmont
   Wetlands State Park Land Management Board were presented to the meeting. Reports
   highlight significant impacts on the coastal ecosystems resulting from recreation
   activities, and need for increased resources to manage.
   The meeting also resolved to undertake a desktop study of current monitoring

# programs to determine whether there is a case for Council to undertake regular heavy metal testing around the lake.

• Pamper Care

Pamper Care assisted nine people and their families, directly through WNC. The outreach program assisted 32 people, mainly men.

Waste to Art

All packed up. A few works still left for artists to pick up. Currently writing evaluation report, and awaiting artist survey responses.

Cane toads

Risk of cane toads spreading into Hunter region. Hunter Local Land Services are setting up surveillance groups, and spotlighting events to monitor local spots and identify any potential cane toad sightings as quickly as possible.
