

3 Hunter Water – Temporary desalination plant proposal

Nicholas Bates and Jordi Bates, and Kate Sullivan Hunter Water Corporation

Key points:

- Hunter Water is seeking to mitigate risks to water supply in the instance of a very severe drought.
- In the case of a very severe drought period, a water source that is independent of rainfall is required to provide some water security.
- A desal plant is a last resort, and construction would only be triggered if water storage drops to 35%. This would allow approx. 1 year for the plant to be built, and assumes the plant would be operational by the time storage dropped to 20%.
- Proposed site is on existing Hunter Water land, adjacent to Belmont Waste Water Treatment Works.
- Water supply and water resilience (including demand management) measures are ongoing, and public messages vary according to current rainfall, storage and consumption needs.
- Noted possible improvements to messaging to use more relevant / meaningful measures of storage capacity and consumption

7.1 Catalogue litter

The issue of catalogue litter has been raised on a number of occasions, by Redhead SN, and most recently by a number of people at the Living Smart Festival. There are 8 billion catalogues printed every year just in Australia, cutting down half a million trees. Most are just thrown from a car onto a front driveway, rather than being delivered to a letterbox. Then there's the litter everywhere...only about 25% are looked at!

Steve has done some internet research, and couldn't find any community campaigns action on the issue.

There is an Australian-wide law that advertising materials need to put in a letterbox, in a newspaper holder, or under a door, not on car windscreen wipers.

There is a code of conduct to not give out where there's a "no junk mail" sign but it is not mandatory and often ignored. Fines are \$200+.

Proposition: that we approach the Boomerang Alliance to mount a campaign to work with the Advertising Industry to work out solutions including non-printing advertising in this war on Waste.

Agreed.

ACTION: Steve to send letter to Boomerang Alliance as above. Can include Planet Ark as well.

Will include a Special General Meeting to update our constitution to be consistent with the new Strategy.

Proposed changes to Constitution circulated via email for comment. Changes have been proposed to:

- Clarify membership status. Individuals join the Alliance directly. Groups are not members.
- Clarify not for profit purpose
- Provide more detail about general membership of the Alliance
- Provide more clarity about decision making
- Provide detail about general meetings.

Much of this detail was missing from the current version. The additions have been made to be consistent with NSW Fair Trading's model constitution for associations.

The new Constitution and notice will need to be circulated by 5 November at the latest, to give two weeks notice.

Seeking approval from board members to put this updated version to the SN membership for adoption at the November Special General Meeting.
