#### 4.2 Business arising from the minutes

The cost for 750 bags is AUD\$73 (=\$0.09/bag). But with the shipping it would be AUD\$204 for 750 bags (=\$0.27/bag).

#### **Background**


The Lake Macquarie Coastal Wetlands Park proposal was initiated by community groups and was formally endorsed by Lake Macquarie City Council in 2005. The park proposal covers 10 separate areas of land over a distance of about 15 km on the eastern side of Lake Macquarie. The total area is 1,730 ha, owned by a number of State Government agencies and Council.

The concept of the park is to provide for cooperative and consistent management of the significant wetland and natural areas, and improve protection and management.

Proposal: That the Alliance support the campaign to progress a Lake Macquarie Coastal Wetlands Park.

#### 7.4 Networking and 'Show and Tell' Event

The Landcare Resource Centre is booked for Saturday 3 December, 2-5pm.

Informal event and opportunity to:

- hear about what each group has been up to;
- share ideas, inspiration, and learn from each other;
- invite Councillors, relevant Council staff

Discussed the possible structure and objectives for the gathering.

Agreed that the most valuable component is for volunteers from across the city to have discussion based around particular topics. For example:

- How have you successfully recruited new members?
- What projects should we be addressing at a citywide level?
- What resources or other organisations have you found useful?
- How do you manage your group dynamics?

Would be good to circulate questions beforehand to give participants some time to think about the topics.

Also to circulate a list of everyone's projects from the last 18 months, prior to the event.

A project presentation could be good to break the ice a bit, and provide some context for discussion to follow.

Suggested a <u>plastic free</u> afternoon tea (avoiding single use packaging and plastics. Tupperware and reusable plastics are good.) Rachelle to provide some basics, and also to ask participants to bring something plastic free.

ACTION: Rachelle to go ahead and organise based on ideas above.

## 8 Requests from member groups

#### 8.1 Wangi Centenary Celebration, Sunday 23 October

Initial event application and risk assessment were circulated via email in September, and the Alliance Board has approved in principle, pending receipt of necessary paperwork, and approval by Alliance insurer and Council.

The event application is still under consideration by Council staff, and awaiting a few final details.

The details were sent to our insurers, and we were notified that:

"in respect to the Jumping Castle we do not cover any claim in respect of entertainment rides involving animals or mechanical devices including but not limited to merry-go-rounds, trains rides, dodgem or other similar cares, air filled castles, pony rides, tractor rides or any other such rides or amusements. As you are the Event organiser you have a responsibility and duty of care and in the event of litigation you could still be pulled into a claim with the Jumping Castle owner. You would be up for any legal fees and litigation outcome. E.g. if the Jumping Castle owner is held 95% responsible and the organiser was 5% and the Litigation Awarded was \$1,000,000 the organiser would be up for \$50,000 plus legal fees to fight the claim."

The possibility of the scouts having a climbing wall was also proposed, but assumed that it would come under the same restriction as the jumping castle.

Based on that advice, the WASNG decided not to have the jumping castle, or climbing wall there. Following some additional requests for information, the insurers have now confirmed coverage for the event (excluding a jumping castle or climbing wall).

The email conversation was circulated via email.

#### 8.2 Greater Charlestown SNG – Request regarding Madeira Vine

Request circulated via email in September. Suggest that we need further consultation with Landcare and Council staff to be able to respond. General agreement that the issue should be referred to Landcare, as they are the experts in community weed management. Greater Charlestown SNG are planning to request a meeting with relevant Landcare and Council staff.

#### 8.3 Cardiff SNG stall at Halloween

Risk assessment circulated via email. Feedback given to ensure the milk cartons are cleaned thoroughly.

## 8.5 Request to Hunter Water Community Consultative Committee from Pelican Area SNG Request circulated via email.

Following the review meeting with the Pelican Area Sustainable Neighbourhood Group, they asked that the Alliance present their request to the Hunter Water Consultative Committee. The request refers to a Hunter Water pipe that is blocking a drainage channel, and results in localised flooding issues.

ACTION: Jean to forward request on to Hunter Water Consultative Committee to request a response about the issue, and report on it at the next committee meeting. Also send a copy of the request through Hunter Water's generic customer service avenue.

## 8.6 Greater Charlestown SNG - Project variation request – Pit Pony Park Rehabilitation Project (Stage 2)

Following further community engagement, an amended project plan has been prepared, with the following changes:

- Exclusion of the excavated sleeper reinforced step. Community feedback confirms that the proposed edging is unnecessary. Instead, the trees will be planted directly into an earthen berm.
- This impacts the budget by removing the need for and cost of extra materials (originally proposed as a cash contribution of \$1,005 from the GCSNG), and increasing the in-kind contribution, as the cost of a excavator driver (\$440) is now being donated.
- This change also impacts the project's expected completion date. We would like to reschedule the community planting day to National Tree Day in July 2017 to avoid hot and dry conditions over summer, and leverage promotion associated with National Tree Day.

It is planned to submit this request to the Stronger Communities Programme grants administrators to ensure they are adhering to the grant agreement.

### 9 Report backs from member groups

#### 9.1 Living Smart Festival

Super weather, and reported attendance of 20,000.

The Sustainable Neighbourhoods stall was busy all day, with 17 volunteers helping out over the day. 300 letters collected, and 137 new contacts for Sustainable Neighbourhood groups.

General feedback about the stall set up was that we could have made better use of the West Wallsend group's waste displays. It was difficult for people to see them, and people were reluctant to enter the space under the marquees. We almost ran out of sign up sheets and blank letters. Would also be good to have some additional clipboards for multiple volunteers to use to collect sign ups at the same time.

The Dudley Community Garden group also thanked the Alliance for assisting with insurance coverage for their stall on the day. They had a similarly successful day.
