4 Previous meeting

4.1 Ordinary meeting minutes, 16 July 2015 as circulated

7.1 Welcome new member group: Cardiff Area Sustainable Neighbourhood Group.

Terms of Reference and initial Membership Register were circulated via email. Launch is set for 11 October, and the group are planning a Plant Swap event.

7.2 Plastic bag ban- responses from MPs so far, and an educational display

- Reply received from Jodie Harrison MP. Stating that she has contacted the Minister for the Environment on the Alliance's behalf, and will forward his response, 7 August
- Forwarded letters from Greg Piper's office, in response to previous (June) letter from Toronto Area SNG:
 - Reply from Greg Hunt (Federal Minister for the Environment), 21 July, endorsing state based regulation for "practical solutions for the phase-down of lightweight nonbiodegradable plastic bags". More information here: www.environment.gov.au/aboutis/mem.

Also encouraged contact with Mr Steve Beaman, NSW EPA on 02 9995 6073 or stephen.beaman@epa.nsw.gov.au.

ACTION: Steve to contact the EPA to find out what their position is

- Reply from Mark Speakman (NSW Minister for the Environment), 28 July, stating support for "practical solutions to reduce the impact of plastic bags in the environment", being led by EPA. Also stated support for plastic bag recycling, and NSW gov announcement to phase out microbeads from personal care products by 2016, and a container deposit scheme by 1 July 2017.
- Responses received in response to an individual letter from Jean:

- o Jill Hall MP (Federal) stating her support for a plastic bag ban, 1 August.
- Feedback and resources from Plastic Bag Free NSW Alliance.
 - They submitted a petition to State Parliament on 4 June with 12,500 signatures moved by Bruce Notley-Smith, Member for Coogee. Tabled on 13 August and debated that day. (Email to Steve from Jeff Angel, Director and Convenor of the Boomerang Alliance)
- Preparation of display materials for Living Smart Festival, and other events.
 - Council is happy to provide the Alliance with some reusable bags to give away.
 - Norbert is collecting plastic bags for a display of the different stages of breakdown.
 - Hard copy of the existing petition.
- Would be good to develop a strategy to make an impact on politicians to demonstrate public support for a plastic bag ban. (eg along the lines of the #putyourbatout campaign for Phillip Hughes)... Eg put your (reusable) bag out on the front step.
- Next campaign action: Focus on local retailers in neighbourhood areas who are keen to go Plastic Bag Free. Utilise the SN network to approach suitable businesses in their area.

Businesses who agree to stop supplying free single use plastic bags to their customers will be promoted on our website and public displays as our community leaders.

Ask SN groups to approach suitable local businesses over the next month, so that we can find some businesses prior to the LSF.

ACTION: Rachelle to include a request for SN groups to approach their local businesses in the next 'Sustainable Neighbourhood News'

- Some discussion about redcycle scrunchable plastic recycling available at Coles.
- Also agreement to seek a meeting with local (state) MPs following the Living Smart Festival.
