

The Sustainable Neighbourhoods Program

Background

Lake Macquarie City Council is committed to caring for our local environment, and making a fair contribution to a happy, sustainable planet. The Sustainable Neighbourhoods Program is a bottom up approach which supports communities to: develop their own neighbourhood sustainability action plan; implement actions that reduce their neighbourhood footprint; and increase their neighbourhood wellbeing.

A Sustainable Neighbourhood Group for Cardiff North

In late 2009, Council met with the Cardiff North Public School P&C to discuss the feasibility of developing a Sustainable Neighbourhood Group in Cardiff North.

With the support of the Cardiff North Public School P&C, on 27 February 2010 Council hosted a Sustainable Neighbourhood workshop for the community to learn about how to create a sustainable neighbourhood.

The workshop was attended by 25 residents. All participants were invited to form a coordinating group to work with Council and residents to develop this Sustainable Neighbourhood Action Plan. The purpose of the plan is to document priority issues by residents to work together on improving their neighbourhood sustainability.


Methodology

Over a period of 18 months, the Cardiff North Sustainable Neighbourhood Group has worked with neighbours and Council through a variety of engagements to collect information about Cardiff North and what matters to residents Our engagements included:

The information collected through these engagements activities have formed the basis of this Cardiff North Sustainable Neighbourhood Action Plan.

This plan belongs to the Cardiff North community and is a living document. It will improve and grow as decided by the Cardiff North community, and in light of changing knowledge and experience. The Cardiff North Sustainable Neighbourhood Group is committed to implementing this plan, and to monitor and review it annually.



Cardiff North - Our Place

Cardiff North is located in the northern part of Lake Macquarie city, NSW, and is the traditional land of the Awabakal people. Cardiff North is predominantly a residential area situated just north of the Cardiff business district.

The Cardiff North Sustainable Neighbourhood area spans two water catchments; which are separated by Reservoir Rd.

The forest, woodland and waterways of Cardiff North support a range of plant and animal species. Some interesting animals sighted in the area include the Pacific Baza, Yellow-tailed Black Cockatoo, Australian King Parrot, Bearded Dragon, Dwarf Green Tree Frog, Peron's Tree Frog and the Sugar Glider.



Cardiff North - Our Community

Based on Census data from 2006, our neighbourhood includes approximately 2,965 people in 964 households, with the following characteristics:

- A relatively younger population (median age is 35 in Cardiff North, compared to 40 in Lake Macquarie)
- A high proportion of family households (79% of Cardiff North, compared to 75% of Lake Macquarie)
- A higher proportion of people living alone (27% of Cardiff North residents live in one person household, compared to 23% for Lake Macquarie)
- A high proportion of residents either fully own, or are in the process of owning their house (83% combined) compared to the rest of the city (74%)
- Less people are renting their home (14%) compared with the rest of the city (20%)
- Residents (\$936mth) are paying higher rents that the rest of the city (\$833mth)
- A higher proportion of residents volunteer in Cardiff North (18%) compared to Lake Macquarie and NSW (17%).



The Communities Attitudes Survey highlighted that the Cardiff North community is very good at recycling (99%), and most (>70%) have water efficient appliances and fittings; insulation; and energy efficient appliances. Many have native gardens (62%) and vegetable gardens (50%). However, a relatively low number (27%) of respondents 'often' or 'always' catch public transport. From those who don't, the main reason is either that the timetable/route is inadequate, or that they prefer to use the car.

Respondents ranked 'a personal responsibility to do the right thing for the environment' as the most important motivator to improve their environmental behaviour, closely followed by 'saving money'.

The survey results also highlighted some of the issues and actions that are important to Cardiff North residents. The most important issues included biodiversity and catchment management (pest animals and plants in particular; infrastructure (cycleways/footpaths); waste (recycling, reduction, disposal and litter); and water pollution (creeks, stormwater).


Survey responses also indicated some actions that are likely to gain popular support from the Cardiff North community, including:

- Provide information, support and resources to encourage worm farming and composting
- Provide education about GreenPower
- Activities which would be most likely to attract broad public participation include:
- Home audit of backyard, energy, waste, and water use
- Neighbourhood clean-up
- Landcare; and
- Sustainable living workshops.









"A neighbourhood that values and enhances our natural environments, minimises our ecological footprint, and provides a friendly, safe and attractive environment".


We want Cardiff North to be a place where:
